What is Metro?

An elected regional government, that serves the three counties and the 25 cities the make up the Portland region.

Responsible for the region's:

- Land use, solid waste and transportation planning
- Regional parks and natural areas
- Convention center, Oregon Zoo, performing arts and exhibit centers



Researchable Questions (5/2015)

Is the project managed to ensure:

1. public benefits are achieved,
2. designs are within budget,
3. construction is being managed to the budget,
4. additional public expenditures are not required,
and
5. repayment of bonds is sustainable?

Risks and rewards

	Audit Risks	Audit Rewards
Prospective	<ul style="list-style-type: none">• Completing audit work on time• Providing enough time for management to address recommendations	<ul style="list-style-type: none">• Avoid getting bogged down in time consuming aspects of the topic• Assessing basics of project management could have multiple benefits
Real time	<ul style="list-style-type: none">• Lack of in-house expertise in construction monitoring• May duplicate management efforts• Reduces ability to address other audit topics	<ul style="list-style-type: none">• Keep management's attention on the most important issues• Verify the accuracy of project updates provided to public and agency leadership
Retrospective	<ul style="list-style-type: none">• Outcomes already determined• Recommendation may not be applicable to future projects	<ul style="list-style-type: none">• Determine what could have been done better• Identify causes that may need to be managed in future projects

Balancing audit rigor against constraints

- 20+ year history of proposed hotel projects
- Complicated funding structure
- Legal challenges
- Changing market dynamics
- Uncertain construction timing

Assumptions

- Project delays could impact management's priorities
- As the project moves to the construction phase the management structure may need to change
- Public understanding about the promised benefits may be less clear after years of stops and starts

Audit start (10/2016)

- Use the scoping phase to assess the project's achievement of the public benefits promised when it was originally approved
- Explore each of the public benefits enough to understand the resources needed to reach a conclusion
- Plan the audit with a fixed end date
