Gene L. Dodaro

Gene L. Dodaro became the eighth Comptroller General of the United States and head of the U.S. Government Accountability Office (GAO) on December 22, 2010, when he was confirmed by the United States Senate. He was nominated by President Obama in September of 2010 from a list of candidates selected by a bipartisan, bicameral congressional commission. Mr. Dodaro has testified before Congress dozens of times on important national issues, including the nation's long term fiscal outlook, efforts to reduce and eliminate overlap and duplication across the federal government, and GAO's "High Risk List" that focuses on specific challenges—from reducing improper payments under Medicare and Medicaid to improving the Pentagon's business practices. As Comptroller General, Mr. Dodaro helps oversee the development and issuance of hundreds of reports and testimonies each year to various committees and individual Members of Congress. These and other GAO products have led to hearings and legislation, billions of dollars in taxpayer savings, and improvements to a wide range of government programs and services.

Timothy M. Persons

Dr. Timothy M. Persons was appointed the Chief Scientist of the U.S. Government Accountability Office (GAO) in 2008. In addition to leading advanced data analytic activities at GAO, he also co-directs GAO's Center for Science, Technology, and Engineering, a group of highly specialized scientists, engineers, and operations research staff. In these roles he directs science and technology (S&T) studies and is an expert advisor and chief consultant to the GAO, Congress, and other federal agencies and government programs on cutting-edge S&T, key highly specialized complex systems, engineering policies and best practices, and original research studies in the fields of engineering, computer, and the physical and biological sciences to ensure strategic and effective use of S&T in the federal sector. Dr. Persons received his B.Sc. (Physics) from James Madison University, a M.Sc. (Nuclear Physics) from Emory University, and M.Sc. (Computer Science) and Ph.D. (Biomedical Engineering) degrees from Wake Forest University. He is a senior member of the Institute for Electrical and Electronic Engineers, serves as an ex officio council member of the National Academy of Sciences' Government-University-Industry Research Roundtable, and has authored an array of journal, conference, and technical articles.

Gloria Jarmon

As Deputy Inspector General for Audit Services at the U.S. Department of Health and Human Services (HHS), Gloria Jarmon is responsible for providing audit services for all HHS programs (with budgets of over \$1 trillion) and directs the efforts of over 600 auditors and staff. She also worked at the U.S. Government Accountability Office (GAO), U.S. Department of Education, U.S. Capitol Police, and KPMG. She was awarded the 2017 Outstanding CPA in Government Federal Impact Award by the American Institute of Certified Public Accountants (AICPA). Kip Memmott serves as the Audits Director for the Oregon Secretary of State's Office responsible for all state audits and auditors. His professional positions include Chief Audit Executive for the Oregon State Treasury, Director of Audit Services for the City and County of Denver, Internal Audit Manager with the County of San Diego, Performance Audit Supervisor with the State of Arizona's Office of the Auditor General, and Senior Consultant with KPMG. He holds a Bachelor of Arts degree from the University of Utah and a Master of Arts degree from Arizona State University. Mr. Memmott is a graduate from the Harvard University Kennedy School of Government's Executives in State and Local Government executive education program and has earned a Certificate in Public Leadership from the Brookings Institute. Additionally, in 2014, the IIA identified the City and County of Denver Auditor's Office as 1 of 11 best practice audit functions for major cities in the U.S. and Canada.

Michael E. Horowitz

Michael E. Horowitz was sworn in as Inspector General of the Department of Justice (DOJ) in April 2012. As Inspector General, Mr. Horowitz oversees a nationwide workforce of more than 450 special agents, auditors, inspectors, attorneys, and support staff. Since 2015, he has simultaneously served as the Chair of the Council of the Inspectors General on Integrity and Efficiency, an organization comprising all 73 federal Inspectors General. Mr. Horowitz has twice held Senate-confirmed positions: in addition to his current position, he served from 2003 to 2009 as a Commissioner on the U.S. Sentencing Commission. Mr. Horowitz previously worked as partner at the law firm of Cadwalader, Wickersham & Taft LLP. He also was a board member of the Ethics Resource Center and the Society for Corporate Compliance and Ethics. Earlier in his career, Mr. Horowitz was an Assistant U.S. Attorney for the Southern District of New York from 1991 to 1999, where he was the Chief of the Public Corruption Unit and a Deputy Chief of the Criminal Division. From 1999 to 2001, Mr. Horowitz worked at DOJ's Main Justice in the Criminal Division in Washington, D.C., first as Deputy Assistant Attorney General and then as Chief of Staff.

Steve Ballmer

Steve Ballmer is co-founder of Ballmer Group and owner of the Los Angeles Clippers NBA basketball team. Mr. Ballmer retired as Chief Executive Officer of Microsoft in 2014 after leading the company for nearly 14 years. Through philanthropy and civic activism, Ballmer Group strengthens approaches that increase economic mobility for children and families in the United States. Mr. Ballmer also leads USAFacts, a project seeking to improve transparency in government, including disclosing taxes and borrowings raised, money allocated and spent, and outcomes achieved, much as corporations do through their 10-K reports. He co-teaches a course at Stanford on understanding government budgets and spending and has taught or lectured on technology, leadership, and innovation at Stanford, Harvard, and the University of Southern California. Mr. Ballmer became Microsoft's CEO in 2000, having served for 20 years in roles as president, senior vice president of sales and support, senior vice president of systems software. and vice president of marketing. He was the company's first business manager. During his tenure at Microsoft, the company pioneered personal computing and democratized enterprise computing, growing from a small start-up to a company that today employs more than 110,000 people. During his tenure, Microsoft grew to almost \$80 billion in revenue and was the third most profitable company in the United States. Mr. Ballmer earned a bachelor's degree in mathematics and economics from Harvard University and attended Stanford University Graduate School of Business before joining Microsoft.

Jeff Romine

Jeff Romine is the Chief Economist for the City and County of Denver, and works directly within Denver's Office of Economic Development (OED). He is the lead staff in working with Denver Mayor Michael Hancock and OED Executive Director Eric Hiraga, working on a wide range of economic, financing, and development initiatives and projects, including addressing involuntary displacement (gentrification) and implementing efforts to attract, retain, and expand companies in Denver. Previously, under Mayor Hickenlooper and Mayor Vidal, he also served as the Director of Business and Housing Services and led the Business Development team. In these roles, Mr. Romine directed the business attraction and development, affordable and workforce housing production and funding, and neighborhood development program activities within the integrated community economic development program. Ron Elving is Senior Editor and Correspondent on the Washington Desk for National Public Radio (NPR) News, where he is frequently heard on air and online as a news analyst and writes for npr.org/politics. He is a regular on the NPR Politics Podcast, consistently a Top 20 podcast on iTunes, and appears in the Facebook series "Ron's Office Hours." He was the senior manager for the Washington Desk from 1999 to 2014. Mr. Elving is also an Executive in Residence for the Department of Government in the School of Public Affairs at American University (AU). He was previously an adjunct professor in the School of Public Affairs and in the School of Communication since 2013 and received the AU Outstanding Teacher award for adjunct faculty in 2016. He had previously taught at AU from 1995-2003, and has also been an adjunct professor at Georgetown University. Prior to his time at NPR, Mr. Elving was the political editor for USA Today and Congressional Quarterly. He has also been published by the Brookings Institution and the American Political Science Association. He has contributed chapters on President Obama and the media and on the media role in Congress to the academic studies Obama in Office (2011), and Rivals for Power (2013). His earlier book, Conflict and Compromise: How Congress Makes the Law, was published by Simon & Schuster. Mr. Elving came to Washington in 1984 as a Congressional Fellow with the American Political Science Association and worked for two years as a staff member in the House and Senate. Previously, he had been state capital bureau chief for *The Milwaukee Journal*. He received his bachelor's degree from Stanford University and master's degrees from the University of Chicago and the University of California at Berkeley.
