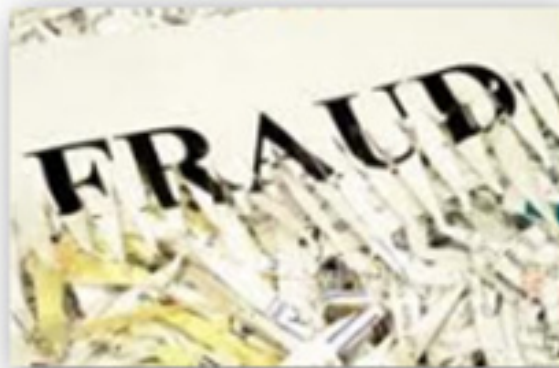

PROCUREMENT FRAUD

- An intentional perversion of truth somewhere in the acquisition process for the purpose of inducing another to part with something of value, or to surrender legal right.



- The misrepresentation is fashioned by a fraudster(s) who has a deep operational knowledge of the procurement process and therefore many times is connected to the contract.

PROCUREMENT ABUSE

Procurement Abuse includes actions like:

- Misuse of authority or position;
- Misuse of access to sensitive procurement information.



*All with the intent to advance one's own interest or those of a family member, friend, or particular contractor.

NON-COMPLIANCE EMPLOYEE

*There are two types of Non-Compliance Employees:
Well-Intentioned and Disengaged*

- Never talked about during courses
- Fraudster and Abuser creates a direct financial loss
- Non-Compliance Employees create an indirect and unnecessary exposure

WELL INTENTIONED NON-COMPLIANCE EMPLOYEE

- Believes their deviation will cause no harm
- Believes their actions add efficiency
- Strong knowledge of your procurement Processes/Requirements
- Does not identify the true scope of the requirements
- Knows key words to say or not say



DISENGAGED NON-COMPLIANCE EMPLOYEE

- Will not perform any of the Schemes
- Opens the organization for the Fraudster
- Little or minimal effort into procurement steps
- Will not check a contractor's bond
- Will not check past performance
- Will not confirm delivery of the product prior to approval for payment
- Disgruntled or dissatisfied employee
- Gallup Poll – 24% - “Actively Disengaged”

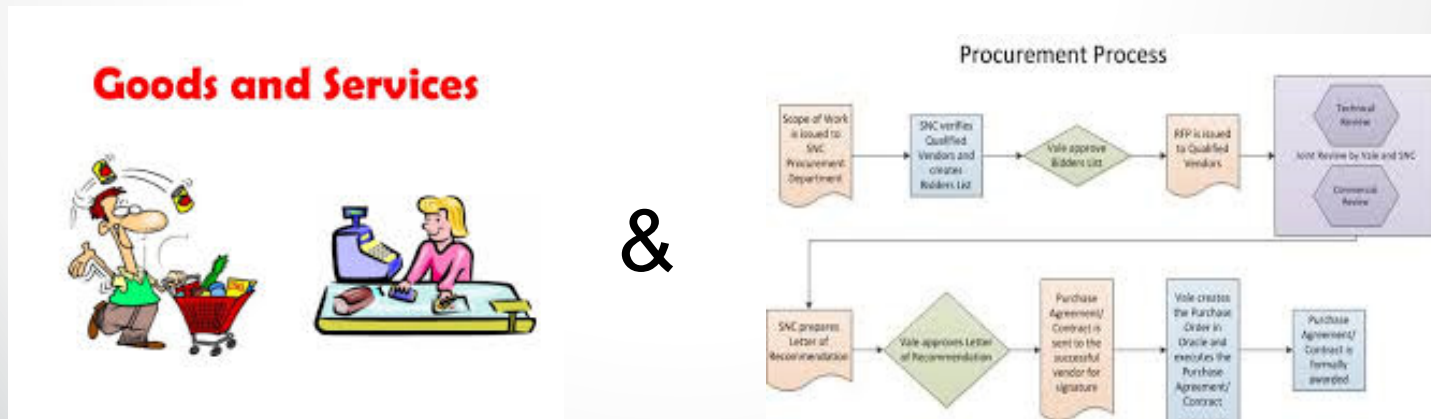

Procurement Integrity Controls are the people, processes, procedures, and/or management systems that are designed to provide reasonable assurance regarding the prevention, detection, prompt reporting, and ability to respond to procurement fraud and abuse.

PREVENTION CONTROLS

Prevention: “The action of stopping something from happening or arising.” (Webster's)

- Segregation of Duties
- Proper Authorizations
- Adequate Documentation
- Background Checks
- Requirements Defined



DETECTION CONTRACTING CONTROLS

Detection: “The action or process of identifying the presents of something concealed.” (Webster's)

- Reporting Mechanism
- Fraud Awareness Training
- Reconciliation Controls
- Surprise Audits

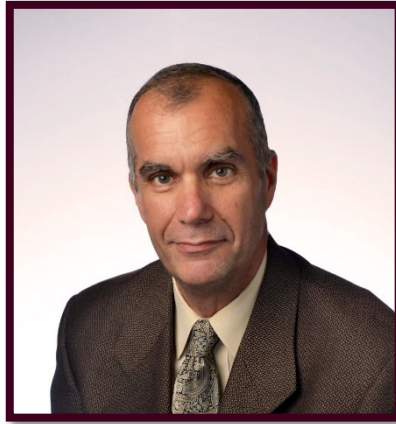
