Learning objectives: Perhaps more than any other state, Hawai'i's uniqueness is its most valuable asset: the Islands' beaches, forests, mountains, and national parks are the main attraction for the visitors that fuel the economy, and the State's agricultural lands are vital to the burgeoning diversified agriculture industry. Its rich cultural history provides a unique perspective to local, national, and international events, and its geographic location makes it an ideal testbed for clean energy solutions and innovation. At the same time, this environment is fragile—it is home to about one-third of all federally listed endangered species in the United States, is vulnerable to invasive plant and animal species that could threaten our remote home's unique biodiversity, and its isolation is a persistent challenge. This presentation will explore the value and importance of ensuring accountability, integrity, innovation, and effectiveness in government to preserve and protect our unique environment.

Session 3: High Risk Areas at the Federal, State and Local Levels of Government

Learning Objectives: In this session, participants will learn how governmental audit agencies are identifying and monitoring high risk programs. These include:

- Federal Level: Learn about how GAO identifies, monitors, and sometimes removes programs from its high-risk program.
- State Level: Learn about California's state high-risk program which is authorized in state law. This segment will address the State Auditor's authority for the program and the steps taken to determine its high-risk programs and functions. These include those particularly vulnerable to fraud, waste, abuse, and mismanagement, as well as those of particular interest to the residents of the State and those that have potentially significant effects on public health, safety, and economic well-being.
- Local Level: Learn about California's new local high-risk program which is authorized in state law. Learn about the high risk local government audit process which includes identifying high-risk local government agencies, performing audits of high-risk local government agencies, public reporting of the results of audits, and following up to determine whether appropriate corrective action has been taken regarding recommendations made.
