Louisiana = Food





Food Safety

- 27.3 million tourists each year
- Approximately 163,000 cases of food-borne illness annually
- *Our objective:* To evaluate the Office of Public Health's regulation of retail food establishments



Inspections

- 81% of inspections not performed as required by risk model
 - Risk model did not consider compliance
- 32% (4,200 of 13,099) of establishments with critical violations were not re-inspected



Enforcement


- Inspections that were conducted cited 450,000 violations over 3 year period
 - Only 4 compliance orders with \$1,300 in penalties issued; but \$0 in penalties actually collected
- 33% of establishments had repeat violations

Example: “raw animal food not separated from ready to eat food or is placed above ready to eat food” was cited 6,688 times with 591 establishments having 15 occurrences of this violation



Transparency

- OPH website did not disclose all inspection results to the public
- Only shows most recent results
- Difficult to understand results
- No reporting of “voluntary” shut-downs
- Should use numerical scores or grades



Food inspection bill passes

Restaurants and other places that sell food will pay higher permitting fees to the state. The Senate gave final, unanimous passage Friday to House Bill 337 by state Rep. Nick Lorusso, R-New Orleans, outlining the increased fees. Gov. Bobby Jindal supports the fee hike.

The dollars will be used to enhance food inspection services at the Office of Public Health. The budget for the 2013-14 fiscal year anticipates the \$1.7 million that will be generated from the bill.

The money will pay for current employees of the retail food inspection program, along with technology upgrades to better-coordinate inspections, supplies and travel costs.

The price tag for a permit varies by type of retail food establishment. Permit costs will be boosted by about 50 percent, according to a Legislative Fiscal Office analysis. Temporary or special event permits, like for fairs and festivals, will be exempt from the fee hike.
