
Outside your control: What the evidence actually might suggest






Within your control: Creating understandable paragraphs and clear sentences

When it comes to audit writing, control what you can control:

- Your paragraphs
- Your sentences
- Your review of your own work

- Make one major point per paragraph, expressed in a topic sentence.
- ► Unify your paragraphs by making each sentence relate to that one major point.
- ► Order your sentences so that they flow one to the next.

Control your sentences

► Minimize p_s_ve voice

► Use lots of verbs

► Keep your sentences short

Control your review

Analyze your document (don't read it!)

Make **separate** passes through the document, looking for big stuff and then small stuff












Always express that one main idea in a topic sentence. Always.



Why are topic sentences so vital for a paragraph?




A topic sentence provides focus for your paragraph; it explains the subject of the paragraph and something about that subject.

The army [subject] has developed plans to establish a new training ground in Kentucky [something about the subject].

The officials discovered that employees bought several prohibited items with their agency purchase cards, such as largescreen tvs, jewelry, and fine cutlery. For example, the officials discovered that employees visited Best Buy stores near their homes to obtain tvs with their purchase cards. The employees also used the cards to buy diamonds and Wusthof knives over the Internet.


In reviews performed on selected expenditure transactions, we identified instances of employees being paid for meal per diems when a contractor had provided the employees the meal being claimed. For example, an employee visited two money managers in California to perform a "due diligence" review. The employee went out with the money managers for various meals and the money managers paid for the meals. One of the money managers paid for a dinner one day and lunch the following day. The other money manager paid for a dinner. The Department paid the employee the per diem regardless.



Tip: "For example," is a good second sentence if you have a strong topic sentence. "Specifically" works pretty well, too.

Tip: If your second sentence begins with "However," you don't have a solid topic sentence.




<u>Closely related to the topic sentence:</u> all sentences in your paragraph should clearly relate to the topic sentence

The closure contract specifies both Kaiser-Hill's and DOE's responsibilities. Kaiser-Hill is responsible for processing, packing, and shipping off-site all of Rocky Flats' nuclear materials and radioactive and hazardous wastes. DOE is responsible for delivering a variety of services and items to support the project. For example, the contract specifies that DOE arrange receiver sites for all the materials and wastes that must be shipped off-site and to obtain the necessary certifications for the containers in which the materials and wastes must be packed and shipped.

Over one million government employees, as well as members of the public work in and visit federal facilities each year. The Federal Protective Service (FPS) is the primary agency with responsibility for providing law enforcement and related security services for the nearly 9,000 facilities that are under the control and custody of the General Service's Administration (GSA). To accomplish its mission of protecting federal facilities, FPS currently has about 1,200 full time employees, and about 15,000 guards deployed at approximately 2,300 of the 9,000 federal facilities across the country. In fiscal year 2009, FPS obligated \$659 million for guard services, which represents the single largest item in its budget.

Order your sentences so that they flow



Make sentences flow by beginning with known information before moving into new information

➤ One type of thunderstorm is known as a "single-cell" thunderstorm. Basically, a single-cell thunderstorm is the lone thunderstorm that forms on a hot humid day. The heat and humidity of the day is the only trigger for the storm. This type of storm forms in an environment with little difference in the wind speed and direction—or wind shear—between the surface and cloud level.

Brief paragraph that breaks the known-new contract



Your sentences should

- Identify "Who is doing what?"
- Primarily maintain active voice
- Use lots of verbs
- Not strain the reader's short-term memory



Your sentences should identify "who is doing what," by maintaining a **subject-verb-object core** as much as possible.


This sentence keeps the core together:

The agency issued guidelines that had to be completely revised just 3 months later.

This sentence does not keep the subject-verb-object core together.

▶ Minimize passive voice.

(Passive: form of the verb "to be" and past participle.)

The requirements were performed by the contractor.

The facilities were managed by the agency.

The employees are harassed by the executives.



Why does passive voice always get a bad rap?

The dismantlement of the organizational structure into component pieces by the agency had the result of a reduction of efficiency.

The dismantlement of the organizational structure into component pieces by the agency had the result of a reduction of efficiency.

The agency reduced efficiency after it dismantled the organizational structure into its components.

Use verbs, not nouns, to express action.

The new law will have an influence on future building.

The new law will influence future building.

We will need to perform an analysis of traffic volumes at this intersection. We will need to *analyze* traffic volumes at this intersection. . . .

The new policy produced benefits for employees. The new policy *benefited* employees.

We can conduct a survey of this lot. We can *survey* this lot.

Too many nouns will achieve the dilution of writing.





- Once program funds are exhausted, states with eligible projects are placed on a reimbursement backlog list by the federal government, which may be built up over several years.




General rule of thumb: keep sentences under 35 words.




Tip: If you think your sentence is too long, read it aloud. If you have to stop and take a breath while doing so, it's too long.

Passive voice minimized?

The administrator and Commission board members are appointed by the Governor. The administrator is subject to confirmation by the Senate. ICOA is responsible for systems development including planning, staff support, and monitoring a variety of service programs for the elderly. Planning functions include needs assessment, data analysis, development of State plans, review and approval of area agency plans, public information, and technical assistance. Monitoring includes technical assistance, training, and program evaluation. Support for the planning and program Operations is provided by fiscal and clerical staff. ICOA is also responsible for being a visible and effective advocate for older persons. It includes the Office of the State Ombudsman for the Elderly.





Verbs?


The registration and regulation of supervising physicians who provide supervision of physician assistants, residents, interns and externs, cosmetic procedures and directing physicians who supervise athletic trainers is also the responsibility of the Board.



Short sentences?

DBO's ability to perform these checks is hindered by limitations placed on staff of regional offices to consult databases in other offices to ensure that an applicant subsidiary's proposed code does not match that of a sister subsidiary already in the program, which DBO officials told us that their rules for the database that stores subsidiary information can restrict the ability of some staff to access this system's data for determining the compliance of sister subsidiaries owned by the same companies that are serviced by different DBO district offices.
